- 5. Tender Submission: Sealed Quotations/Tender documents (with signed specification-annex-1 and price format-annex-2) will be received in the tender box at Logistics Dept. of BDRCS, NHQ, Dhaka latest by 07 May 2024 at 11:30 AM marking on top of envelop- "Procurement of 02_unit of Vehicle" and must be accompanied by all the information/documents as per RFQ. Tender/Quotations will be opened at 11:45 AM on 07 May 2024 at the Meeting Room of BDRCS, NHQ in presence of bidders if any.

6. Delivery/installation destinations:

All fully assembled Vehicles are to be delivered and must be useable at BDRCS National Head Quarter, Dhaka BDRCS. Supplier shall be responsible for all costs arising from delivery and assembling/services of the Vehicle to actual point of delivery including BRTA registration, TAX Token under BDRCS, marking, loading, unloading, transportation and first party insurance. BDRCS authority will inform the selected supplier of the detail delivery plan (in written) and the supplier will be fully responsible to deliver completely assembled vehicles with services as per work order.

- 7. Quality Criteria: The Vehicle must comply with the specifications and must be ready for operation. All the Vehicles must be in good condition and be ready without any damage and interruption.
- **8. Delivery/Completion Period:** The contract period for the work will commence immediately after signing the contract/receiving the work order. The Vehicles must be completely assembled and ready to be operational at the destination within 90 working days.
- 9. Price: Price should be quoted in the given format in annexure 2, and as per Unit (per Vehicle) in BDT (Bangladeshi Taka) inclusive of all costs with ost, loading, unloading, transportation, packing, marking (Logo), labelling (text), taxes, duties, levies and first party insurance etc. for delivery at the destination mentioned above in clause 4. Income Tax & VAT will be deducted at source as per Govt. rules at the time of final payment. In case of any arithmetical discrepancy between the unit rate and the total amount quoted, then the unit rate shall prevail for the evaluation of quotations and for the subsequent supply.

10. Required Documents/Certificates:

- 13. Inspection on the completion of the work: Fully assembled Vehicle must meet the required specifications and must conform to our standard specifications mentioned in this schedule. Quality inspections will be carried out by the BDRCS inspection team. If the fully assembled Vehicles do not meet the specification, will not be accepted by the BDRCS and in that eventuality, the supplier must replace the Vehicle and bear the inspection cost and/or other losses/penalty, as may be fixed by the buyer.
- **14.** Liquidated Damages: Complete delivery of the Vehicles after mutually agreed delivery schedule will be subject to deduction of damages/penalty from the invoice per day up to maximum 0.05% of the total value of the contract for a maximum period of 30 days. If the supplier fails to deliver the Vehicles after 30 days of the delivery period, the contract will be null and void and the earnest money and the security money will be forfeited besides other action for non-performance of the contract.
- 15. Payment: Within 30 days from the date of submission of invoice/bill with all supporting documents i.e. commercial invoice, duly signed delivery challan by the field personnel (BDRCS/IFRC/British Red Cross) and the satisfactory delivery with full assembled and operational of the Vehicles with inspection report.

16. All price offers should clearly state the following:

- a) Unit Price of the item, and total amount for the delivery (including words/language)
- b) Price should be net after deduction of any discount and should be inclusive of all cost, taxes, and duties (Please refer to clause -09).
- c) Confirm dates for completion of delivery of the Vehicle at delivery points along with the *detail* delivery plan/schedule if necessary.

17. Pertinent Information:

Vehicle is required for Operational support and therefore it is essential that Vehicles are delivered as a matter of urgency.

- 18. Tender Security/Bid Amount: Bidders must submit along with their quotation a bid amount of 2.5% of the total quoted amount in the form of Pay Order/Demand Draft/Bank guarantee in favour of the Bangladesh Red Crescent Society from the scheduled bank. Cheque will not be accepted. Bid amount of unsuccessful bidders will be returned as soon as the purchase contract (s) is signed with the successful bidder(s). Bid amount of successful bidder will be added with Performance Security/Security Money. Offers not accompanied with the adequate bid amount will not be considered. For any reason the bid amount if taken back by any bidder before the final decision then their quotation/tender will be considered to be invalid. If the work-order/purchase contract not accepted by the successful bidder within 10 calendar days after invitation to sign contract/agreement the bid amount 2.5% will be forfeited.
- 19. Security Money /Performance Security: The successful bidder(s) will have to deposit 7.5% of the total value of the contract/order as performance security in the form of a pay order/demand draft/bank guarantee from the scheduled bank in favor of Bangladesh Red Crescent Society at the time of signing the contract/purchase agreement/order. This security money/performance bond will be refunded after 06 (six) months of satisfactory completion of the total contract (defect liability period). If the contract is partially cancelled due to the non-performance by the supplier, all rights of refund of security money will be forfeited. Earnest money may be adjusted with Security money for qualified bidders.
- 20. All or None Clause: BDRCS reserves the right to accept or reject any or all offers, and the lowest bid need not be accepted without assigning any reason. Failure to comply with any of the above requirements will justify rejection of the quotation. Should your offer be accepted, you will be required to sign, stamp and return our formal Purchase Contract(s) confirming your acceptance of the agreed terms and conditions as per this RFQ.

- 22. Principles of Conduct Clause: The Supplier seeking to work with the BDRCS shall respect the following principles:

 - **b.** Business Ethics: The Supplier is expected to maintain the highest degree of business ethics when working with the BDRCS.
 - c. Transparency of information provision: Contractor/Supplier shall not be involved in any fraudulent activities, misrepresent information or facts for the purpose of influencing the selection and contract awarding process in its favour.
 - d. Fair competition: Supplier shall not be involved in any corrupt, collusive or coercive practices.
 - e. Officials not to benefit: The Supplier represents and warrants that no official of the BDRCS has been, or shall be, admitted by the Contractor to any direct or indirect benefit arising from this Tender/Request for Quotation, Work Order/Contract or the award thereof. The Contractor agrees that breach of this provision is a breach of an essential term of this Tender/Work Order/Contract. If at any time during tender or the supply process the BDRCS determines that the Contractor/supplier is in violation of the abovementioned principles, that Contractor's request for registration or bid may be rejected as ineligible.
